Heritage Preservation Commission

Created in 1971, the Heritage Preservation Commission (HPC) is a 10-member commission comprised of persons living within the City of Minneapolis who possess a demonstrated interest, as well as professional experience and expertise, in preservation work.

New Appointees

The HPC received three new first-term commissioners in January: Laura Faucher, Robert Mack, and Jody Tableporter.

Laura Faucher was appointed to fill the vacancy created by the resignation of Deborah Morse Kahn whose term was to run through December 31, 2012. Laura is a registered architect with 18 years of experience and is a member of the American Institute of Architects (AIA), the Association of Preservation Technology, and the Preservation Alliance of Minnesota (PAM).

Robert Mack, appointed to his first 3-year term to run through December 31, 2014, has been practicing preservation architecture for over 40 years and taught graduate-level preservation classes at the University of Minnesota College of Design. Bob is a Fellow of the American Institute of Architects, a recipient of the Steve Murray Award, and authored the first two Preservation Briefs for the National Park Service's Secretary of the Interior's Standards for Rehabilitation.

Jody Tableporter, also appointed to her first 3-year term to run through December 31, 2014, is employed as Executive Director with Voyageur's National Park Association and has worked as a real estate investment manager, including a 10-year career in the UK in "urban regeneration". Jody has been awarded fellowships with the Harvard Design School as well as the Lincoln Land Institute in Cambridge, MA.

Resignations and Term Limits

September saw the resignation of **Kevin Kelley**, whose employment required relocation to Arizona. Kevin served as a valued member of the commission since 2007, attending nearly 120 meetings, was the HPC representative for the St. Anthony Falls Heritage Board, and was a member of the Hennepin County Historical Society. Kevin could always be counted on to keep discussions and motions moving along during deliberations and his influence contributed greatly to the commission.

Chad Larsen's term limit will come to an end in December, having served on the HPC since 2004, attending nearly 200 meetings, and chairing them for the past five years. With a calm and professional organizational style that will be sorely missed, Chad's very capable leadership served the commission and City of Minneapolis well as he guided the HPC through many major projects including the Warehouse District merger and over twenty new local or national designations.

32nd Annual Statewide Historic Preservation Conference

The 32nd Annual Statewide Historic Preservation Conference was held in Fergus Falls, MN, on September 12 through 14.

The following staff attended the conference: Hilary Dvorak, Becca Farrar, Aaron Hanauer, Janelle Widmeier, and Aly Pennucci from Development Services; John Smoley from Zoning Administration and Enforcement; and Jim Voll from Community Planning.

Tammy Lindberg, current commissioner and HPC's 2012 Secretary, also attended the conference.

CPED Organization Structural Changes

On January 1, 2012, the Planning Division of CPED began operating within a new organizational structure. The elimination of one of four planning manager positions prompted CPED to re-organize the Planning Division so that the business lines were delivered through three sections instead of four. The Preservation and Design section was dissolved, and staff who had worked in that section were reassigned into the remaining three sections: Development Services, Community Planning, and Zoning Administration and Enforcement.

Development Services

Hilary Dvorak, Interim Planning Manager of Development Services, oversees the responsibilities of the HPC which reviews all public hearing items including Certificates of Appropriateness (CofAs) and Demolitions of Historic Resources. Diana Armstrong and Aaron Hanauer were both moved into the Development Services section from the Preservation and Design section and join Lisa Baldwin, Becca Farrar, Kimberly Holien, Aly Pennucci, Shanna Sether, and Janelle Widmeier.

Community Planning

Jack Byers, Planning Manager of Community Planning, oversees the review of designations, creation of design guidelines, and other long-range preservation planning efforts. Brian Schaffer was moved to Community Planning from the Preservation and Design section and joins Mary Altman, Joe Bernard, Beth Elliott, Haila Maze, Paul Mogush, and Jim Voll.

Zoning Administration and Enforcement

Steve Poor, Planning Manager of the Zoning Administration and Enforcement arm of CPED-Planning, oversees administrative review work including Certificates of No Change (CNCs) and wrecking reviews. John Smoley and Chris Vrchota were both moved into the Zoning Administration and Enforcement from the Preservation and Design section and join Brad Carter, Robb Clarksen, Brad Ellis, Stuart Roberson, Anne Rolandelli, Paul Smith, Jake Steen, Steve Weckman, and Michael Wee.

These organizational changes have allowed the Planning Division of CPED to fully integrate preservation practices, policies, and ideals into the everyday work of all staff teams in Planning.

Public Outreach and Education

Preservation Awards

The 21st Annual Preservation Awards Ceremony and Luncheon was held May 17th at the International Market Square. Cosponsored between the HPC, the Minneapolis Chapter of the American Institute of Architects, and Preserve Minneapolis, the awards recognize individuals and projects that promote and enhance heritage preservation in Minneapolis.

Historic Restoration, Rehabilitation, or Adaptive Reuse

Projects for nomination in this category are those where an existing place, property, building, or landscape was returned to its original character in a manner respectful to the property's historic past. This year the **Ford Center**, 420 5th Street North, was honored as a model for the rehabilitation of a landmark building that serves as an anchor for a redeveloping area of the Warehouse District that incorporated thoughtful new design while respecting historic features like windows, facades, and the concrete structure.

New Addition to a Historic Building

Projects for nomination in this category are those where an addition was made to an existing place, property, building, or landscape in a manner respectful to the property's historic past. Awards went to both the **Municipal Building Carving Project**, Minneapolis City Hall, 350 South Fifth Street, for meticulously completing (more than 100 years later) the original architect's intent of carving the building's name and date of construction into the granite above the main entrance, and to the **Cowles Center**, 528 Hennepin Avenue, for incorporating two historically designated buildings, one alley, and one open surface parking lot into an acclaimed arts center in downtown Minneapolis.

Preservation Planning

The *Warehouse District Heritage Streets Plan* was honored for the project team's diligent work to incorporate the various perspectives of engineers, planners, neighborhood residents, and preservation experts in resolving infrastructure conflicts.

Community Education and Advocacy

Meant to recognize organizations and their preservation-related education and outreach projects, there were two awards from this category given this year. **Friends of the Cemetery** was honored for their innovative advocacy efforts, in particular for their first-ever benefit concert at the Minneapolis Pioneers and Soldiers Cemetery located at 2925 Cedar Avenue South. **Whittier Alliance** was honored for creating a Historic Preservation Neighborhood Calendar, an example of innovative educational resources.

The Steve Murray Award

Considered the top individual honor for preservation in Minneapolis, The Steve Murray Award is awarded to an individual who exemplifies leadership, courage, and dedication to heritage preservation in Minneapolis. The 2012 Steve Murray Award was presented to Kathleen **Anderson** for her years of service and dedication to the City and to the Heritage Preservation Commission, on which she served from 1987 to 2010. Kathleen attended more than 500 meetings and participated in countless deliberations instrumental to historic preservation in the city.

Designations

Local Individual Designations

The Heritage Preservation Commission recommended, and the Minneapolis City Council approved, the following landmark designations:

• Edward & Gusty Rappaport House

636 Elwood Avenue North

Designation: November 18, 2011

A two-story house designed in a vernacular style with Colonial Revival and Craftsman influences. Eligible under Criteria #2, property associated with the lives of significant persons or groups.

• Viehman Residence

2006 Laurel Avenue West

Designation: January 13, 2012

A two and a half-story house designed in the Queen Anne Style. Eligible under Criteria #2, property associated with the lives of significant persons or groups, and Criteria #4, property embodies the distinctive characteristics of an architectural or engineering type or style or method of construction.

National Register of Historic Places (NRHP) Nominations

The HPC commented favorably on the following NRHP nominations:

• Elizabeth Quinlan Residence

1711 Emerson Avenue South

A two-unit house, L-shaped in plan, and standing three-stories high. The building exhibits many characteristics of the Renaissance Revival sub-genre of the Eclectic architectural style. Eligible under National Register Criteria #C, property embodies the distinctive characteristics of a type, period, or method of construction, or that represent the work of a master, or that possess high artistic values, or that represent a significant and distinguishable entity whose components may lack individual distinction.

• Buzza Company Building

1006 West Lake Street

A three- to seven-story factory building designed in a restrained Commercial Style and exhibiting some modest Classical Revival features. Eligible under National Register Criteria #A, property associated with events that have made a significant contribution to the broad patterns of our history.

• Lincoln Bank Building

730 Hennepin Avenue

An eight-story, flat-roofed building. Eligible under National Register Criteria #A, property associated with events that have made a significant contribution to the broad patterns of our history.

• Northwestern National Life Insurance Building

430 Oak Grove Street

Beaux Arts, flat-roofed office building with five facades. Eligible under National Register Criteria #A, property is associated with events that have made a significant contribution to the broad patterns of our history; and Criteria #C, property embodies the distinctive characteristics of a type, period, or method of construction, or that represent the work of a master, or that possess high artistic values, or that represent a significant and distinguishable entity whose components may lack individual distinction.

Permits & Design Review

The Minneapolis Heritage Preservation Ordinance requires the HPC and CPED staff to review alterations to landmarks, property in historic districts and properties under interim protection. Additionally, the ordinance requires CPED staff to review all wrecking and moving permits issued by the City to determine whether the affected property is an historic resource. If CPED staff determines that the property is an historic resource, the demolition requires approval by the HPC.

Certificates of Appropriateness

The HPC reviewed 41 applications for a Certificate of Appropriateness.

Historic Variances

The HPC reviewed and forwarded two Historic Variance applications to the City Council for approval. The City Council approved both variances.

Demolition of Historic Resources

The HPC reviewed nine applications for the Demolition of an Historic Resource and approved eight.

A Demolition of an Historic Resource application for Peavey Plaza, 1101 Nicollet Mall, went before the HPC on April 17, 2012. The HPC denied the application, but the action was appealed and the appeal was approved by City Council. A National Register of Historic Places (NRHP) designation application for Peavey Plaza is currently under consideration.

Certificates of No Change

CPED staff administratively reviewed 123 Certificate of No Change applications for minor alterations that did not change the historic integrity or visual character of the property.

Wrecking Permits

CPED reviewed and approved a total of 216 wrecking permits.

Heritage Preservation Files and Inventory

Community Planning and Economic Development (CPED) is located in room #300 of the Public Service Center Building, 250 South 4th Street, and retains landmark nominations and survey forms for properties in the city as well as inventory files for designated districts and other potentially historic properties. Some of these materials are in survey form and typically contain brief descriptions of the resource or building, an approximate date of construction, a statement of significance, and a photograph. For locally designated properties, CPED maintains records on applications that have gone before the HPC for approval, as well as minutes from HPC meetings. There is also a collection of books maintained on the history of Minneapolis.

Research and Contacts

Survey and research information is available to the public during normal business hours. Those interested in researching any potential or known historic resource are encouraged to call for an appointment with CPED staff to discuss their specific needs or to view the HPC collection.
