This crash involved one vehicle leaving the roadway, striking property. Officers located the driver of the suspect vehicle. A confrontation ocurred. Officer(s) discharged their duty weapon(s). The suspect fled on foot and officers pursued.

The suspect was taken into custody and transported to the Hennepin Healthcare Hospital. The suspect was arrested and identified as David Peake, 43, and is in the Hennepin County Adult Detention Facility on a Probable Cause hold of Felon in Possession of a Firearm.

The Minnesota Bureau of Criminal Apprehension responded to the scene and are conducting the investigation. The officers involved had their body worn cameras on and activated.
