Minneapolis Police officers responded to the 2400 block of Emerson Avenue North on a report of a person shot and lying in the roadway. Officers arrived and located an adult female who had been shot. A confrontation occurred with an armed adult male and shots were fired. Officers started CPR on the individual and responding medics pronounced him dead at the scene. The adult female that had been shot was transported to an area hospital by ambulance with non-life-threatening injuries. Body cameras were on during this incident. The scene was secured and the Minnesota Bureau of Criminal Apprehension was requested to conduct the investigation.
